Invoice addresses and transition to electronic invoicing

We at Nordic Paper have transitioned to handling our supplier invoices electronically.

We have developed three alternatives for you to deliver your invoices. At firsthand, we want E-invoices, and secondarily, we want PDF-invoices.

E-invoice

- For You already sending us electronic invoices, we ask You to contact your einvoice operator (VAN-operator) and ask them to do the set-up, in accordance with the information in the attachment. GLN-number for each Nordic Paper company is found in the attachment.
- VAN-operator: Scancloud AB (Addett)

E-invoice Peppol

 For You sending us electronic invoices via the European standard PEPPOL, use peppol-ID in accordance with the attachment.

PDF-invoice

• If You, from your enterprise resource planning system, can print out your invoices as PDFfiles, you should send these to the e-mail address for each individual company stated in the attachment. One invoice per PDF-file, if the invoice has an appendix this should be attached in the same pdf-file as the invoice.

Note! Scanned PDFs will not be accepted.

Possible order number is always consisting of six digits and MUST be in the order field. Other reference information should be in the reference field. Reminders or others is sent to ekonomi@nordic-paper.com
